5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Town Hall, Bridge Street, Peterborough, PE1 1GF by 5pm on Tuesday, 21<sup>st</sup> April 2026 . You may apply online or download a form at <https://www.gov.uk/apply-postal-vote> or contact the Electoral Registration Office directly.
